Execute a successful event

- What is this for and what are wanting to accomplish with this event

- How do these objectives fit into your budget

Timing deadlines to be established

- You are advised to organize every detail as early as possible
- Encourage potential participants to sign up and commit by sending out information early
- Get sponsor commitments first and iron out the details later

Format of play and competition

- Two-person best ball or Texas Scramble
- Competitions: Closest to the Pin, Longest Drive, Closest to the line, Longest Putt, etc

Golf Tournament Contract:

- _____ A non-refundable deposit to guarantee regular tournaments of \$250 for up to 25 players; \$500 for 26-50 players; \$750 for 51 to 72 players; and a non-fundable \$500 fee/deposit to guarantee all shotgun starts. A deposit is required 30 days prior to secure the tournament date. Tournaments will be confirmed only upon receipt of deposit and request form completed.
- _____ The remaining balance must be paid in full by the organizer to Sherwood Forest Clubhouse prior to the first tee time.
- _____ The tournament organizer is responsible to supply a copy of the draw to Sherwood Forest 24 hours prior to the event and to arrive one hour prior to the event.
- _____ Shotgun starts are at 1:00pm only Monday, Thursday and Friday May through to September. Saturday and Sunday bookings allowed in May, June and September.

- _____ Standard golf attire is in effect. Shirts must be worn at all times. It is the responsibility of the tournament organizer to enforce the dress code during their tournament.
- _____ All alcohol consumed on the golf course must be purchased through the clubhouse restaurant or the bar cart on the golf course. Absolutely no outside beverages permitted on the course.
- _____ Power cart users must obey course rules regarding access to fairways.
- _____ Course Marshals and Starters have sole authority on the golf course.
- _____ Additional carts, for organizers, volunteers etc. must be reserved at the time of booking.
- _____ It is the responsibility of the organizer to ensure all rules of the course are adhered to by their respective tournament guests, participants, and organizers.
- _____ The tournament convener and/or holder of the credit card on file for the tournament is responsible for any damage to the golf course, power carts, rental clubs, equipment, clubhouse, banquet facilities, or adjacent property caused by tournament patrons. Sherwood Forest will not be held responsible for any lost, stolen, or damaged property during the event day. All property including signage, promotional material, etc. must be picked up with 24 hours after the event. By signing the tournament application, the organizer agrees to hold Sherwood Forest and its employees free of any liability or other claims.
- _____ The guaranteed number of players must be confirmed to Sherwood Forest at least seven (7) days prior to the tournament date. This confirmed number of players becomes your guarantee and minimum charges will be based on such numbers. All shotgun events will be charged the shotgun deposit fee regardless of the total number of players. Sherwood Forest reserves the right to alter starting times, or format should the number of players differ greatly from the original booking.
- _____ I the organizer, acknowledge that I have read and agree to the terms and conditions stipulated in this agreement.
